

# The Wedding Checklist Contest Rules & Regulations

1. Agreement: These rules govern The Wedding Checklist Contest (the "Contest"). No purchase is necessary to enter the Contest. The act of entering the Contest constitutes acceptance of the Contest rules and the decisions of the Sponsor, which decision shall be final and binding on all entrants.
2. Sponsor: The Contest sponsor is Premier Publications & Shows, a division of Metroland Media Group Ltd. ("Sponsor").
3. Eligibility: The Contest is open to residents of Ontario that have reached the age of majority as of the start of the Contest Period. Notwithstanding the above, the Contest is not open to employees, immediate family members (i.e. spouses or biological, step or adoptive parents, children or siblings) or anyone domiciled with any employee of the Sponsor or any prize supplier or any of their respective affiliates, subsidiaries, advertising or promotional agencies or fulfillment houses. Incomplete or illegible entries, bulk drop offs, photocopies, scanned copies, facsimiles or other mechanically or electronically reproduced entries will not be accepted and will be disqualified. Limit of one (1) entry per person.
4. Contest: Pick up the Wedding Checklist ballot at the Registration Table at The National Bridal Show held at the Enercare Centre, Hall D 100 Princes Blvd, Toronto ON M6K 3C3 from February 3-5, 2017. To enter the Contest without paying the show admission fee, please ask at the show's Exhibitor Registration Booth and a volunteer will escort you inside to complete the entry process. Complete the ballot by visiting all participating vendors and having your ballot stamped. Fill in the back of the ballot with all required information and deposit the ballot at the Registration Table before you leave the National Bridal Show. The Contest begins at 5:00 pm ET on Friday, February 3, 2017 and closes at 4:00 pm ET on Sunday, February 5, 2017. The potential winner will be chosen by random draw, which will take place at the National Bridal Show at 4:15 pm ET on Sunday, February 5, 2017 at the Registration Table. If the potential winner is not present at the time of the draw, he or she will be contacted by telephone or email by a representative of the Sponsor, and must reply within 48 hours to maintain eligibility. If a potential winner cannot be contacted within this time period or fails to respond to any attempted contact, such potential winner will be disqualified, his/her entry will be declared null and void and the Sponsor reserves the right, in its sole and absolute discretion, to select at random another eligible entry, in which event these provisions shall apply to such other eligible entry. In order to

be eligible to win, the winner must correctly answer a mathematical skill-testing question without assistance or mechanical or electronic aid.

Approximate retail value of the grand prize is ten thousand five hundred and fifty (\$10,550.00) dollars CDN. The Sponsor reserves the right to cancel or modify the Contest or the Contest rules at any time without notice. The Sponsor reserves the right to substitute any prize or any portion of a prize with a prize of equal or greater value. All prizes are awarded as-is and no warranties or guarantees are implied or expressed. Neither Sponsor nor any prize supplier shall be liable for any lost, late, misdirected, damaged or stolen entries or inability to process entries, or any errors, injury, damage or negligence that may arise in connection with this Contest, including technical issues or failures on any website, app or software, viruses, website disruptions, malfunctions or website down-time, human error, personal injury or property damage incurred by any Contest entrant. Neither Sponsor nor any prize suppliers are responsible for any errors or omissions in printing or advertising this Contest. Use of any automated system including robotic or form filling software to enter or participate in this Contest is prohibited and will result in disqualification of all entries by anyone using such assistance.
